Objectives and Investment Policy

Franklin Euro High Yield Fund (the “Fund”) aims to earn high income and, secondarily, to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

- lower-quality debt securities issued by governments and corporations located in any country, especially those denominated in euros

The Fund can invest to a lesser extent in:

- other types of euro-denominated securities, including equity securities and higher-quality debt securities
- derivatives for hedging, efficient portfolio management and/or investment purposes
- securities in default (limited to 10% of assets)

The Fund will seek to remove currency risk by hedging non-euro investments to the euro. The investment team manages corporate debt securities’ risk through the detailed examination of individual companies and specific industries to assess their credit worthiness.

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

The benchmark of the Fund is the ICE BofA Euro High Yield Constrained

Index. The benchmark is used solely as a reference for Investors to compare against the Fund’s performance, and the benchmark is neither used as a constraint on how the Fund’s portfolio is to be constructed nor set as a target for the Fund’s performance to beat. The Fund can deviate from the benchmark.

You may request the sale of your shares on any Luxembourg business day.

For the distribution share class shown in this document, dividend income is distributed to shareholders.

Terms to Understand

Debt securities: Securities representing the issuer’s obligation to repay a loan at a specified date and to pay interest.

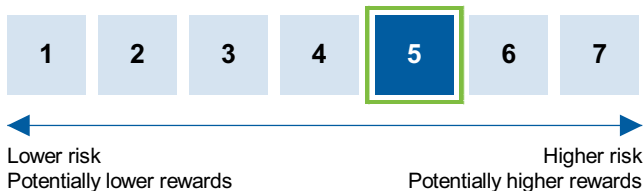
Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Equity securities: Securities that represent an ownership stake in a company.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

Securities in default: Debt securities whose issuer condition has become uncertain and whose issuer is failing to make principal or interest payments when due.

Why is the Fund in this specific category?

The Fund invests mainly in lower-quality debt securities denominated in euro.

Such securities have historically been subject to price movements, generally due to interest rates or movements in the bond market in general. As a result, the performance of the Fund can fluctuate considerably over time.

Risks materially relevant not adequately captured by the indicator:

Credit risk: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, sub-investment-grade securities.

Derivative Instruments risk: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.

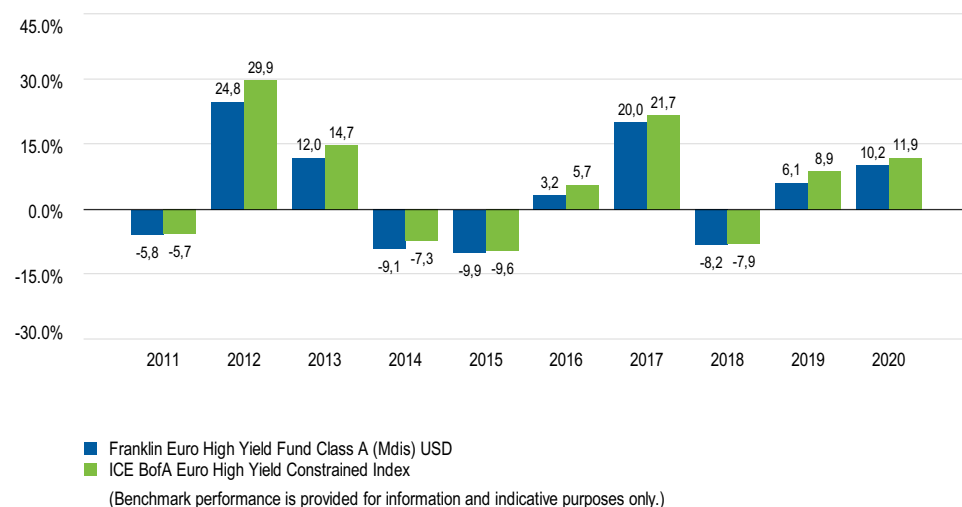
