Objectives and Investment Policy

Franklin Euro Short-Term Money Market Fund (the "Fund") aims to preserve capital while seeking to maximize its investment return in euros over the short term. The Fund qualifies as a short-term variable net asset value money market fund under the European Money Market Fund Regulation.

The Fund invests mainly in high-quality Money Market Instruments such as:

- short-term debt securities of superior quality issued by governments, government-related entities and corporations
- commercial paper issued by first-rate companies
- certificate of deposit of prime banks

The Fund can invest to a lesser extent:

- repurchase/reverse repurchase agreements
- eligible securitisation and asset-backed commercial paper
- deposits and cash
- units or shares of other short-term Money Market Fund (less than 10% of the Fund's assets)

The Fund invests only in securities that are denominated in euros with an

average maturity not exceeding 397 days.

You may request the sale of your shares on any Luxembourg business day.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

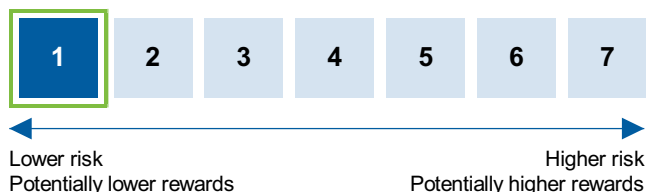
Terms to Understand

Debt securities: Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

Money market instruments: Financial instruments that are normally dealt in on a money market such as treasury bills, certificates of deposit and commercial papers and excluding instruments of payment.

Maturity: The date on which the issuer of a debt security is due to repay the amount originally agreed upon.

Why is the Fund in this specific category?

The Fund invests mainly in very short-term debt securities of superior quality

and money market instruments issued in euro by any government or corporation worldwide. Such securities have historically proven to be highly stable and conservative in nature.

Risks materially relevant not adequately captured by the indicator:

Counterparty risk: the risk of failure of financial institutions or agents (when serving as a counterparty to financial contracts) to perform their obligations, whether due to insolvency, bankruptcy or other causes.

Credit risk: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, non-investment-grade securities.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.

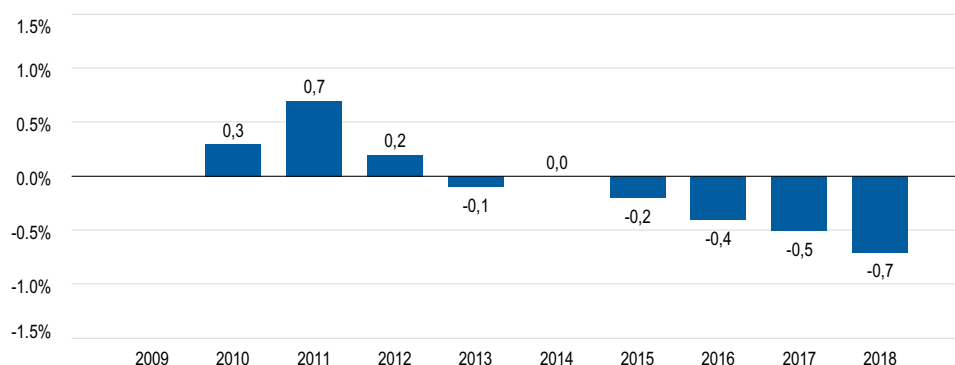
