Objectives and Investment Policy

Franklin GCC Bond Fund (the "Fund") aims to maximise total investment return by achieving an increase in the value of its investments, earning income and realising currency gains over the medium to long term.

The Fund invests mainly in:

- debt securities of any quality (including lower quality and securities in default) issued by governments, government-related entities or corporations located in Gulf Cooperation Council (GCC) member countries, and issued in any currency

The Fund can invest to a lesser extent in:

- debt securities issued by governments, government-related entities or corporations based in the wider Middle East and North Africa regions, or issued by supranational entities (like the International Bank for Reconstruction and Development)
- structured products (such as Sukuk which under normal market conditions may represent 10% to 30% of the Fund's net assets)
- derivatives for hedging and investment purposes
- mortgage- and asset-backed securities

In making investment decisions, the Fund's investment team uses a mix of detailed research into securities, macroeconomic views and quantitative analysis. The majority of their investment decisions are based on their detailed research into economic trends in countries across the globe and each debt security. They conduct thorough analysis to assess each securities overall contribution to portfolio risk and investment return, before deciding whether it

should be included in the portfolio. The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

You may request the sale of your shares on any Luxembourg business day.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

Terms to Understand

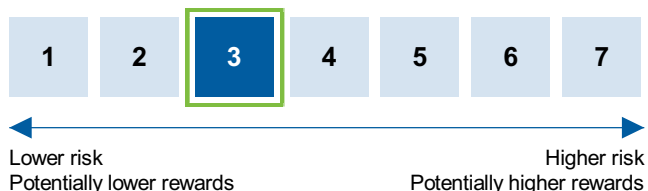
Structured products: Packaged financial products whose value is generally linked to underlying asset(s) that are typically created to satisfy a need that cannot be met by investing solely in standard financial instruments available in the market.

Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

Asset-backed securities: Debt securities whose value and income payments are derived from a pool of underlying assets.

Why is the Fund in this specific category?

The Fund invests mainly in debt securities issued by any type of entity located in Gulf Cooperation Council (GCC) member countries. Such securities have historically been subject to price movements, generally due to interest rates or movements in the bond market. As a result, the performance of the Fund can fluctuate moderately over time.

Risks materially relevant not adequately captured by the indicator:

Credit risk: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, non-investment-grade securities.

Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

Emerging markets risk: the risk related to investing in countries that have less developed political, economic, legal and regulatory systems, and that may be impacted by political/economic instability, lack of liquidity or transparency, or safekeeping issues.

Derivatives risk: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

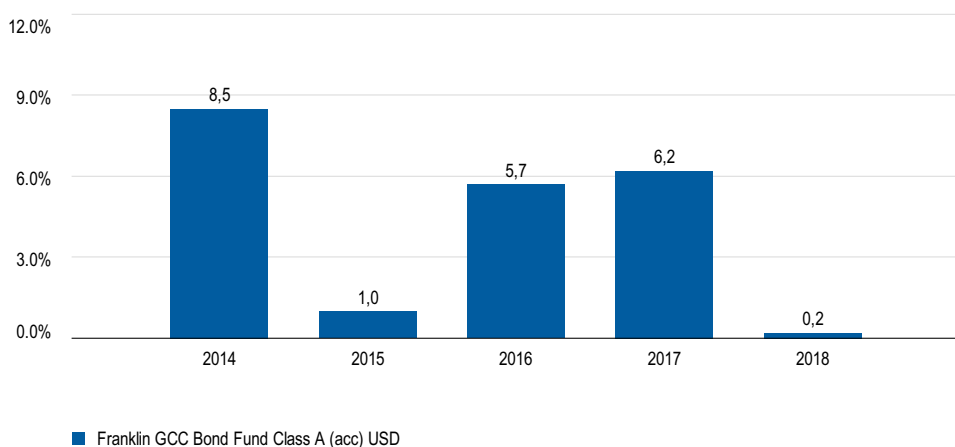
