Objectives and Investment Policy

Franklin Euro Short Duration Bond Fund (the "Fund") aims to preserve capital and liquidity while seeking to maximize its investment return over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

- short-term high quality debt securities denominated in Euro issued by European sovereign issuers and European and/or non-European corporations

The Fund can invest to a lesser extent in:

- lower-quality debt securities such as non-investment grade securities or securities in default (limited to 10% of the Fund's assets)
- debt securities denominated in non-Euro currencies (limited to 10% of the Fund's assets)
- credit-linked securities and structured products
- derivatives for hedging, efficient portfolio management and investment purposes

In making investment decisions, the Fund's investment team refers to detailed analyses of economic trends in various countries and individual companies.

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

The benchmark of the Fund is the Bloomberg Euro Aggregate (1-3Yr) Index.

The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

You may request the sale of your shares on any Luxembourg business day.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

Terms to Understand

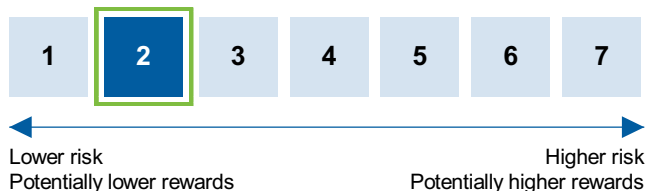
Debt securities: Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

Securities in default: Debt securities whose issuer condition has become uncertain and whose issuer is failing to make principal or interest payments when due.

Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

Why is the Fund in this specific category?

The Fund invests in relatively short-term debt securities denominated mainly in Euros but may invest up to 10% in non-Euro denominated issuers. Such securities have historically been subject to price movements, generally due to

interest rates or movements in the bond market. As a result, the performance of the Fund can fluctuate to a small degree over time.

Risks materially relevant not adequately captured by the indicator:

Credit risk: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, sub-investment-grade securities.

Foreign Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

Derivative Instruments risk: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.

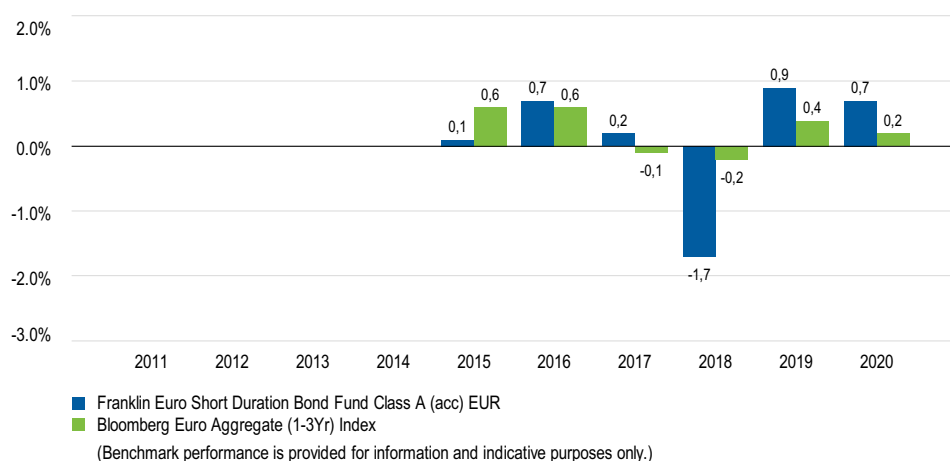
